# High Court grants bail to gangster Ravi Pujari's 'aide' Obed Radiowala

THE BOMBAY High Court on Wednesday granted bail to Obed Radiowala, an alleged aide of gangster Ravi Pujari, in connection with the case of attempted firing at film producer and director Mahesh Bhatt.

Radiowala was apprehended in the US and was in the custody of the US Immigration and Customs Enforcement since September 2017 for illegal stay in the country.

He faces trial for the 2014 conspiracy of firing at Bhatt and another case of conspiracy to fire at filmmaker Karim Morani.

Justice Bharati H Dangre on August 10 passed the order while hearing Radiowala's bail plea.

Radiowala, along with 13 others, is an accused in a case registered with the Mumbai Police. Among them, 12 were tried by the special court under the Maharashtra Control of Organised Crime Act (MCOCA). On April 25, 2018, the remain-

ing two - Radiowala and Sarwan Inder Singh - was named as wanted accused in the case.

Acquitting all the accused under MCOCA, the special court on August 10 said that there was no evidence against the absconding accused and others and no link has been established between them.

Eleven people, however, were convicted for the offence of criminal conspiracy and murder among others under Indian Penal code (IPC).

Thereafter, Radiowala was arrested, as he was deported from the US following a Red Corner notice issued against him. He was produced before a special court in Mumbai on April 3, 2019, and sent to custody. He is facing charges under IPC and the Arms Act.

The HC perused the chargesheet and noted that Radiowala has been accused of arranging financiers from the US and money was allegedly transferred to his brother Anis, a co-accused. The court said that since acquittal has been granted for an

offence under MCOCA, as far as the offence of criminal conspiracy and murder is concerned, "barring the confessional statement made by the co-accused, there is no material against the present applicant, prima facie, indicating him".

"The connection between the present applicant and co-accused cannot be looked at with suspicion since the two are brothers," it noted.

Justice Advocate Nazreen Khatri, appearing for Radiowala, said that the amount was advanced by Obed to Anis for taking care of their mother.

Dangre said that prima facie, in absence of concrete material leading to Radiowala's guilt, merely on the allegation that Rs 6-

7 lakh was transferred to his brother's account, further incarc-

ation is unnecessary. "He shall, however, face trial."

The HC directed Obed to be released on bail on furnishing a personal bond of Rs 50,000 with sureties of like amount. He

has to surrender his passport before the special court within seven days of his release. It also directed Obed not to tamper with evidence and to regularly attend trial.

## Man behind temple theft held

A 32-YEAR-OLD man was arrested by the Shivaji Nagar police for allegedly committing a theft in a temple at Gowandi.
