Sri Lanka's Attorney General on Tuesday asked the police chief to conduct an urgent and full-fledged investigation into the violent clashes between anti- and pro-government protesters in the country that has killed at least eight people and injured over 200 others.

Violence erupted in Sri Lanka on Monday after supporters of former prime minister Mahinda Rajapaksa attacked peaceful anti-government protesters demanding his ouster over the country's worst economic crisis that led to acute shortages of staple food, fuel and power. Over 200 people have also been injured in the violence in Colombo and other cities.

Attorney General Sanjay

Rajaratnam has advised the Inspector General of Police (IGP) to conduct a full-fledged investigation into the incidents of unlawful interference into the people's constitutional rights, the circumstances that led to them; and, the consequent commission of penal offences in the process, News First news portal reported.

In a letter to the IGP, the Attorney General said that as the incident in metropolitan Colombo triggered sporadic acts of violence of serious nature involving people and their property all over the country, he advised the police chief to further investigate the aftermath of the incidents, the report said. He also urged the IGP to complete the investigation on an urgent priority basis.

Slain photojournalist Danish Siddiqui to get 2nd Pulitzer

Slain photojournalist Danish Siddiqui is among four Indians honoured with the prestigious Pulitzer Prize 2022 in the feature photography category. Siddiqui and his colleagues Adnan Abidi, Sanna Irshad Mattoo and Amit Dave from the Reuters news agency won the award, announced on Monday for images of Covid's toll in India that belatedly offered viewers a heightened sense of place, according to the Pulitzer Prizes website. Their work was moved



from the breaking news photography category by the judges. Siddiqui, 38, was on assignment in Afghanistan last year when he died.

The award-winning journalist was killed in July last while covering clashes between Afghan troops and the Taliban in Spin Boldak district of Kandahar city. This is for the second time that Siddiqui has won the Pulitzer Prize. He was honoured with the prestigious award in 2016 as part of the Reuters team for their coverage of the Rohingya crisis. He had extensively covered the Afghanistan conflict, the Hong Kong protests and other major events in Asia, Middle East, and Europe.

Russia pounds Odessa with hypersonic missiles

Russia pounded Odessa, Ukraine's vital southern port of Odessa, Ukrainian officials said Tuesday, as they announced they found the bodies of 44 civilians in the rubble of a building in the northeast that was destroyed weeks ago. The bodies were found in a five-story building that collapsed in March in Izum, about 120 kilometers from the city of Kharkiv, which has been under sustained Russian attack since the beginning of the war in late February. Earlier, the Ukrainian military said Russian forces fired seven missiles a day earlier from the air at the crucial Black Sea port of Odessa, hitting a shopping center and a warehouse. One person was killed and five were wounded.

Ukraine alleged at least some of the munitions used dated back to the Soviet era, making them unreliable in targeting.

Ukrainian, British and American officials have warned that Russia is rapidly expanding its stock of precision weapons and may not be able to quickly build more, raising the risk of more imprecise rockets being used as the conflict grinds on. That could result in wider damage and more civilian deaths.

\$195 mn for Warhol's iconic Monroe portrait

Andy Warhol's 'Shot Sage Blue Marilyn' - a portrait of iconic American actress Marilyn Monroe - was sold for a whopping USD 195 million and set a record for the most expensive artwork by a US artist sold at an auction. The 1964 portrait, painted in vibrant close-up - hair yellow, eye-shadow blue, and lips red - on a turquoise background, was auctioned on Monday shows Monroe in vibrant close-up - hair yellow, eye-shadow blue, and lips red - on a turquoise background.

According to Christie's auction house in New York, where the sale took place, Warhol's portrait is the most expensive piece from the 20th century ever auctioned, as per the NY Press news.

The previous record-holder was another modern master, Jean-Michel Basquiat, whose 1982 painting 'Unframed' of a skull-like face sold for a record USD 110.5 million at Sotheby's in 2017.

The identity of the buyer remains unknown as the auction house said that an unnamed buyer made the purchase Monday night. Following the announcement of the auction of this magnificent portrait last year, the estimates were for as much as \$200 million. Alex Rotter, chairman of Christie's 20th and 21st-century art department said, "It's an amazing price.

Ghatkopar-based madrasa booked for playing azaan on loudspeaker before 6 am

THE MUMBAI POLICE on Sunday registered an FIR against a Ghatkopar-based madrasa for allegedly violating noise pollution norms by using loudspeakers to recite the morning azaan. The azaan was recited prior to 6 am, which is against Supreme Court guidelines that bans use of loudspeakers between 10 pm and 6 am.

Last week, two persons working in two Mumbai mosques were booked for violating noise pollution norms by playing azaan on loudspeakers before 6 am. An officer said that a notice has been issued to the madrasa, located on Amrit Road in Ghatkopar (West), had played azaan on loudspeakers. We shall provide permission if the madrasa does not flout any rules related to the Supreme Court order that restricts use of loudspeakers between 10 pm and 6 am.

Last week, the police had registered FIRs in connection to mosques located at Bandra and Santacruz. This comes in the backdrop of MNS Chief Raj Thackeray giving May 3 deadline to the state government to re-tool noise loudspeakers from mosques.

Pranjapati kept telling the police that Yadav's male friend was behind the murder but they saw traces of blood in his fingernails after which they put him through "sustained questioning", said Balwant Deshmukh, Senior Inspector with Sakinaka police station. During questioning, Pranjapati broke down and confessed to the crime. The police also recovered the murder weapon from him.

Blood in fingernails gives 22-yr-old man away, arrested for estranged wife's murder

THE SAKINAKA police arrested a 22-year-old man on Tuesday, hours after he allegedly murdered his 20-year-old estranged wife by stabbing her with a knife on her neck.

The incident took place around 6 am on Tuesday on Khairani road where the de-

ceased, Reema Yadav, lived alone. The complainant, Rohit Ravidas, 18, a tailor who was Yadav's friend, discovered her body lying in a pool of blood at around 7.30 am.

He called the police which quickly checked her phone and CCTV camera footage of the area to get leads in the case. They called Yadav's husband Manoj Pranjapati, a daily wage labourer, for questioning.

Pranjapati and Yadav were from Uttar Pradesh and had got married in 2020. Six months ago, Yadav and his in-laws, Chandival, Anandi (East), over domestic quarrels with him and his mother, Ravidas had met her the two became friends and for the past 10 days, Ravidas had been providing Yadav with food as she had lost her job.

Power comes & goes, nobody is permanent: Raj Thackeray to CM

MNS chief Raj Thackeray on Tuesday wrote to his cousin and Chief Minister Uddhav Thackeray questioning the arrest of several of his party workers in wake of the protest launched by him against the use of loudspeakers at mosques.

In his letter, Raj Thackeray warned his cousin that power would not remain with him forever. "Nobody in politics stays in power forever. Power comes and goes. With you too, it will not remain forever," he wrote. Raj Thackeray said that 28,000 MNS workers were served prohibitory notices by the police and many have been put behind bars by the state government. "I have only one thing to say: Don't test our patience. Power comes and goes, nobody is permanent. Not even you Uddhav Thackeray!"

Court acquits woman booked for 'slapping' cop during scuffle

A 44-year-old woman, booked for allegedly slapping a police constable during a scuffle caused over the closing time of a pub in Mumbai on New Year's Eve was recently acquitted of all charges by a sessions.

The court said that the probe was "incomplete" and the prosecution had "miserably failed" to produce sufficient evidence, including lack of any independent witness though there were about 200 people present at the pub when the incident took place.

The prosecution said the woman was demanding that music be played at the pub beyond the closing time of 1.30 am. The accused claimed that the pub had taken money from patrons, saying that it will remain open till 4 am.

The prosecution claimed that as she and others were demanding a refund at the pub, the police on patrolling duty heard the commotion and entered the pub. While in the initial statement, the constable had claimed that she was slapped by the accused, while the accused's hand had touched her cheek. "Slapping a police person with intent to prevent or deter him from discharging his official duty and touching the cheek of a police person when the accused was caught from being behind to rescue herself, are two distinct and distinguishable facts," the court said, adding that the constable had not clarified what actually did take place.
