## Chargesheet filed against Ranas for 'resisting arrest, obstructing police'

THE MUMBAI Police on Wednesday filed a chargesheet against MP Navneet Rana and her husband, MLA Ravi Rana, in connection with an offence registered against them for allegedly resisting arrest and obstructing police, who had visited their Khar residence after their announcement that they will chant the Hanuman Chalisa at the private residence of Chief Minister Uddhav Thackeray in April.

This was the second FIR registered against the couple after one filed on sections including sedition. No chargesheet has been filed so far in the case in which

charges of sedition were invoked against the couple and they were arrested as well, before being released on bail. The chargesheet filed before the Borivali court on Wednesday is under sections 353 (assault or criminal force to deter public servant from discharge of his duty) and 34 (common intent) of the Indian Penal Code.

The couple was arrested on April 23 after their announcement about chanting Hanuman Chalisa at Matoshree, the private residence of Thackeray. While the couple had submitted that their announcement was to enlist public support and that they had withdrawn it, the Mumbai Police had said that their intention was to cause public disorder and challenge law and order in the state to

an extent that dissolution of the present government could be recommended.

A special court had granted them bail on May 4, stating that 'decisive ingredients of Section 124A (sedition) of the IPC are not

made out at this stage'.

A second FIR was filed against them on April 24. The couple had approached the Bombay High Court, through their lawyer Rizwan Merchant, to quash this FIR claiming that the relevant sections could have been added to the earlier FIR. Special Public Prosecutor Pradip Charat had opposed their plea, stating that the two incidents were different.

He had submitted that when police officers had repeatedly requested the couple to withdraw their announcement, citing security concerns it raised, they "were not in a mood to hear" them and instead, in "a passionate manner", the couple "flatly refused to cooperate with the police officers".

The couple also argued with

the officers and when they requested the petitioners to enter the police vehicle, they gave threats to officers, according to the chargesheet.

The 85-page chargesheet also includes statements of 23 witnesses, including police personnel who were at the spot. "The accused threatened us that they are MP and MLA, and that we cannot arrest them. They tried to put pressure on us and asked us to leave, knowing well that we had come to arrest them. We did not find CCTV camera footage from the spot but we found video footage shot by other people and mediapersons, which shows them resisting arrest and obstructing us from discharging duty," said a police officer.

## Pillion riders without helmets to face fines from today

THE MUMBAI Traffic Police has said they will initiate action from Thursday against pillion riders not wearing helmets. Raj Tilak Roushan, DCP Traffic (Central & HQ), confirmed the development.

A fine of Rs 500 will be imposed on the pillion rider not wearing a helmet and the biker, too, runs the risk of having his/her driving licence suspended for three months if found riding without the protective headgear.

The police said traffic constables will also act against bikers riding on arterial roads, including highways, as the probability of accidents occurring on such thoroughfares are much higher than on internal roads.

## SALMAN KHAN THREAT LETTER

### Crime Branch team to quiz gangster Bishnoi in Delhi

THE MUMBAI Crime Branch on Wednesday sent a team to Delhi to question gangster Lawrence Bishnoi in connection with the threat letter sent to Salim Khan and his son, actor Salman Khan. The Crime Branch is conducting a parallel probe in the matter while the Bandra police is investigating the case. The threat letter, found near Khan's residence in Bandra, stated, "Salim Khan, Salman Khan bahot jald aapka Moosewala hoga... G.B. L.B... (Salim Khan, Salman Khan, very soon you will meet Moosewala's fate.)" It is

speculated that G.B. and L.B. may refer to gangsters Goldy Brar and Lawrence Bishnoi.

A senior police officer said, "While we are not sure that the threat letter was sent by the gangsters, we do not want to leave any possibility unexplored. Hence, we have sent a team to Delhi to question Bishnoi, who is in the custody of Delhi Police." Delhi Police has taken custody of Bishnoi in connection with an earlier case of supplying arms to other gangsters. An official said they are hoping to question Bishnoi along with a team from Delhi Police. Bishnoi's name first cropped up in connection with the murder of Punjabi singer Sidhu Moosewala.

## Court to decide today on pleas by Deshmukh and Malik to vote for RS polls

A SPECIAL court will on Thursday decide on the pleas filed by arrested NCP leaders Anil Deshmukh and Nawab Malik seeking permission to vote in the Rajya Sabha elections to be held on Friday. The court heard daylong arguments by their lawyers and the Enforcement Directorate (ED), which has opposed the pleas stating that prisoners have no voting rights.

Senior lawyer Amit Desai, representing Malik, said a permanent order was not being sought to attend the Vidhan Sabha but only a permission to be able to go for voting for a few hours with police escort. Desai submitted that as an MLA, Malik was a public representative and had a duty towards his constituency.

"I want to discharge my duty towards my constituency. Courts frequently grant permission to prisoners to light the pyre when a parent dies or to give away a daughter in a wedding considering these as a duty. My ability to cast a vote fails, I am prejudiced, my party is prejudiced," Desai submitted on behalf of the senior NCP leader.

Senior lawyer Abad Ponda, representing Deshmukh, submitted that restrictions under the Representation of People Act cited by the ED to claim that prisoners have no voting rights are only in certain categories of prisoners who are in confinement.

It was submitted that the restrictions apply to convicts and not undertrials against whom allegations are yet to be proven.

The lawyer submitted that the leader can be permitted to be taken to the Vidhan Sabha, where the elections will be held, with police escorts for a few hours and returned to prison.

It was submitted that the validity of the vote is to be decided by the returning officer at Vidhan Sabha but they first need the court's permission to be taken there.

The lawyers also cited that Chhagan Bhujbal, who was behind bars in 2017 in connection with an alleged money laundering case, was also permitted by a special court to go to the legislative assembly and vote during the presidential elections.

Deshmukh is lodged at Arthur Road jail while Malik is currently admitted to a private hospital. Both have been arrested by the ED in separate cases of alleged money laundering.

Additional Solicitor General Anil Singh opposed the submissions stating that the Act states that a person confined in prison cannot vote in any elections, whether he is an under-trial or convict.

Special Judge RN Rokade will pronounce the order on Thursday.

## Anil Deshmukh, two staffers file for bail in corruption case

*Mumbai:* Former state Home minister Anil Deshmukh and his two staffers on Wednesday filed for default bail in the corruption case filed against them by the CBI.

Deshmukh, Sanjeev Palande and Kundan Shinde filed for bail claiming that the CBI had filed an 'incomplete' chargesheet against them. The CBI filed the chargesheet on June 2. Citing some media reports that had claimed that the chargesheet was of 59 pages, their lawyers alleged that it was 'incomplete'.

They filed for bail under section 167 (2) of the Criminal Procedure

Code (CrPC), which has provisions for bail in case the investigating agency does not file a complete chargesheet against the accused within the prescribed time limit.

The special court, meanwhile, has asked the CBI to file its reply in the matter by Monday.
