The Company had availed the e-voting facility offered by National Securities Depository Limited for conducting remote e-voting by the shareholders of the Company.

The shareholders of the Company holding shares as on the 'cut-off' date of **Friday, January 26, 2024** were entitled to vote on the resolutions as contained in the Notice.

The voting period for remote e-voting commenced on **Friday, February 2, 2024, at 9:00 a.m. (IST) and ended on Saturday, March 2, 2024, at 5:00 p.m. (IST)**. The e-voting module was disabled by NSDL thereafter.

The votes cast under remote e-voting facility were thereafter unblocked.
