6	Tata Capital Financial Services Limited ('TCFSL'), a subsidiary of Tata Capital Limited, was allotted fully paid-up equity shares of Tata Steel Limited pursuant to the Scheme of Amalgamation of Tata Steel BSL Limited into and with Tata Steel Limited on November 23, 2021.
7	The total number of shares include 4,370 ordinary shares on which first and final call money has been received and the equity shares have been converted from partly paid-up equity shares to fully paid-up equity shares but, are pending final listing and trading approval under the ISIN INE081A01020 (fully paid-up shares), and hence, continue to reflect under the ISIN IN9081A01010 (partly paid-up shares) as on March 31, 2023.
