Greetings: Where the above named plaintiff have files a plaint in this Hon'ble Court against you the above named defendants whereof the following is conclse statement viz:

- a. That the Hon'ble Court be pleased to declare that the Defendant No.1 to 8 are legally liable to execute **Exhibit A & B** herein above i.e. the Allotment letter and Agreement for sale dated 23/10/1985 bearing registration No. P-859/1986 admeasuring 200 sq.ft.in building known as Vaishali Co.Op.Housing Society constructed on Sub Plot no. B, Plot No.5 forming part of Survey No. 136, Hissa No.3, Bandra(E), C.T.S No.611 of City Survey of Bandra as prescribed under MOFA Act and fulfill all the clauses and terms as per **Exhibit A & B** as arising thereof in favor of the plaintiff along with necessary permissions and to amend the plans so as to give effect wherever necessary to the execution of **Exhibit A & B**.
- b. Alternatively the defendant No. 1 to 8 be directed to pay the present plaintiff compensation as per the market value of the suit premises prevailing at the time of judgment in the present matter with regards to 200 sq.ft.;
- c. That the Hon'ble Court be pleased to restrain the Defendant Nos. 1 to 9 by an Order of permanent injunction from converting the Flat No. 3 (Also known as Flat No. B-1) admeasuring 200 sq.ft.in building known as Vaishali Co.Op.Housing Society constructed on Sub Plot No. B, Plot No.5 forming part of Survey No. 136, Hissa No.3, Bandra (E), C.T.S No.611 of City Survey of Bandra to society office premises.
- d. That this Hon'ble Court be pleased to direct the Defendant No.1 to 9 by a Mandatory Order to reserve the Suit Premises as described in the Para No.1 exclusively for the Plaintiff and not to deal and/or create any third party rights therein.
- e. That on completion of construction as per prayer clause (a) on Suit Plot by Defendant Nos. 1 to 8, this Hon'ble Court by and mandatory Order direct Defendants Nos. 1 to 8 to deliver quiet, vacant and peaceful possession as per Exh. A and B and till then not to dispossess the plaintiff of the remaining 104.6 sq.ft. held/possessed by the Plaintiff;
- f. That Hon'ble court be pleased to restrain the Defendant No.1 to 9 by an Order of permanent injunction from amending the plans without the specific consent of the Plaintiff in construction/ redevelopment of the Vaishali Co.Op.Housing Society on the Suit Plot.
- g. That the Hon'ble Court be pleased to restrain the Defendant Nos. 1 to 9 by an Order of permanent injunction from dispossessing the plaintiff of the remaining 104.6 sq.ft possessed by the Plaintiff;
