Hours before he ended her

life, the police said the woman had gone live on Facebook, where she said that she could

not trust anyone.
On the basis of the suicide On the basis of the suicide note and the video, the police said that a man, who is a resident of Kandivali, had taken Pathak's Activa car in June and refused to return it. "Owing to the lockdown, she could not travel, Despite asking him to return the Activa several times, the man refused to do so," said an officer

Another person, employed with Wisdom Producer Another person, employed with Wisdom Producer Company, duped her into investing Rs 10,000 on the promise of getting a higher interest rate, said police. "The person failed to return her money and was not responding to her calls or messages. These two men have apparently instigated her to end her life." Said the officer.

week, Pune municipal areas have seen more patients recover from Covid-19 and fewer new cases. Between July 31 and August 6, a total of 9,688 patients recovered from the infection in the Pune Municipal Corporation (PMC) areas, while 8,600 new virus cases were research to the contract of the pune. ere recorded. On at least five days during the period, recoveries have outnumbered new cases, civic officials said.

PMC monitors weekly data ending every Thursday. According to officials, if the trend continues for at least two weeks at a stretch, it could signal a slowdown in the

it could signal a slowdown in the spread of the disease.

So far, Delhi has shown a similar trend for almost a month.

Pune has witnessed a jump in the number of active infection cases since the outbreak, however, only 1.162 fresh cases were recorded between July 24 and 30 as compared to the 6,409 cases recorded the preceding week, berecorded the preceding week, be-tween July 17 and 23.

The highest number of active

cases on a single day so far has been 18,215, recorded on July 30. Thereafter, the PMC registered more recoveries than new infec-

more recoveries than new infec-tion cases, bringing the active cases tally to 16,975 on August 6. Pune civic body had tested a maximum of 45,007 patients in the week from July 17 to 23 and also identified the highest num-ber of 11,730 new cases in the same week. Over last seven days, a total of 172 deaths week reported which

172 deaths were reported, which is two per cent of the total new patients and an increase from 1.9 per cent the week before. As on August 6, the mortality rate in the PMC area was reported at 2.35 per cent with 1,456 deaths. State nod to declare 2,011 sq km Angria Bank as protected area, Centre's approval awaited

CHIEF MINISTER Uddhav Thackeray, while pre-siding over a meeting of the 29-menher State Board for Wildlife (SBWL), on Friday approved a proposal to Gedrae the 2.011 sq km Angria Bank as a protected area. The proposal will now be sent to the Centre for its approval. The proposal sought to declare Angria Bank – a submerged plateau 120 km off the coast of Malvan – as a "designated area" under the Martime Zones Act, 1976. If approved by the Centre, it will be the first such marine protected zone in India located in the exclusive economic zone (EEZ).

Other proposals approved by the board, which met after two years, included declaration of Sonneratia Alba as the state mangrow tree and a recovery programme for Arabian Sea Humpback Whale Whales Whalesarshtra became the first state in the country to declare a state mangrow tree, it will have to wait for the Centre's nod to make the recovery programme a reality.

Uddhav, meanwhile, said that from now on development projects will be approved only af-ter conducting drone surveys and receiving en-

ter conducting drone surveys and receiving en-vironment impact assessment reports. The Widdlife Institute of India had identified Angria Bank as one of India's 106 important coastal and marine biodiversity areas. The pro-posed area is approximately 61 km in length and around 50 km in width. According to a study, Angria Bank is home to rich marine biodiversity, including species found under schedule 1 of the Wildlife Protection Act, 1972. The protected status will restrict theas:
