### **NEW SOPs SOON**

## Minister: Schools to reopen as scheduled with precautions

### EXPRESS NEWS SERVICE

EVEN THOUGH the state is witnessing a rise in Covid-19 cases, there won't be any change in the plan of reopening schools after the summer break on June 13, school Education Minister

Varsha Gaikwad said on Sunday. The minister said that a new The minister said that a new set of Standard Operating Procedure (SOP) will be issued to ensure all precautions are taken as students across all stan-dards attend offline classes after a gap of two years. The SOPs will also decide whether the mask mandate should be brought back

into the offline mode.

"The school education department has been cautious throughout the pandemic. Whenever schools have opened in the past at places with lower Covid cases, the required SOPs were put in place to ensure all precautions are taken. If required 1 process of SOPs will be considered to the place to the

precautions are taken. If required, anew sert 50°Ps will be declared in the future too," said Gallowad, adding that there is no decision on closing schools as yet despite the rise in fresh cases. "In the past two years of the pandemic, the children have already suffered amajor academic loss due to the closure of schools. This would be the first day of the school in offline mode for many

in class 2 and lower classes, who inclass 2 altitudes classes, with started school amid the pan-demic. Considering all these fac-tors, especially students' aca-demic and overall growth, the schools will start with all re-quired precautions," the educa-tion minister said.

The statement by the minister clarified the doubts of concerned parents regarding the re-opening of schools amid the rise




