DELAY OVER NEW COURT COMPLEX

Realise space constraints, don't compel us to pass drastic orders: HC

THE BOMBAY High Court on Thursday pulled up its Building Works Department (PWD) for delay in providing details on steps being taken for handing over approximately 30-acre land allotted in Bandra (East) for the construction of a new HC complex...

The HC said its administration has to face constraints due to lack of space every time, including the organisation of recording the solemnisation ceremony of 11 judges...

The court asked the state to file its affidavit within two weeks. A division bench of Chief Justice Devendra Kumar Upadhyaya and Justice Arif S. Dector was hearing a contempt petition by lawyer Ahmed Abdi that claimed the government's non-compliance in a 2018 high court order on land allotment...

On March 10, the HC asked the state to file an affidavit detailing steps taken so far for handing over vacant possession of the said land and whether any plan was laid out by the state government to shift or relocate employees residing on the said land in the government colony/quarters...

On Thursday, Additional Government Pleader Abhay L. Patil for state government submitted that a few meetings of government officers were conducted in the matter and based on instructions from PWD department, however, an affidavit could not be filed and sought more time for the same.
