Serum Institute submits fresh data for Covishield emergency approval

KAUNAIN SHERIFF M NEW DELHI, DECEMBER 22

JUST TWO weeks after the expert committee scrutinising applications for emergency use authorisation (EUA) of Pune-based Serum Institute of India's Covid-19 vaccine sought additional late-stage safety and efficacy data, the firm has submitted fresh data to the regulator, government sources said.

"Serum Institute India has submitted additional data. The regulator's office, internally, will review these documents. Only then they will request the Subject Expert Committee (SEC) to meet," sources told The Indian Express

Significantly, the media has reported that the UK regulator is set to "clear" the Oxford-AstraZeneca vaccine, "possibly on December 28 and December 29". In India, SII which sought EUA from the Drugs Controller General of India (DGCI) on December 10 was asked to submit safety data on Phase 2/3 clinical trials in India of its vaccine candidate named Covishield, developed by Oxford-AstraZeneca.

THE CBI has arrested a man in Kashmir for allegedly running a child sex abuse racket along with his US-based wife. The accused, identified as Niyaz Ahmed Mir (35), was Tuesday produced before a special court in Srinagar, which remanded him in CBI custody

Mir's wife, identified as Tamara Stanley (34), is a resident of Washington. She was arrested on June 25 this year and was "charged with production of child pornography", according to a US Justice Department statement.

CBI said the couple allegedly targeted minors in the US and "uploaded pornographic videos and images over the dark web for financial gains" and were "also involved in direct communication



Lions prey on 10 cows at gaushala in **Rajkot village**

A PRIDE of 10 lions entered a gaushala and preved on 10 cows in Arab Timbadi village of Rajkot district early on Tuesday. A team of forest department that was tracking the pride, however, reached the spot and saved 25 other cattle heads in the gaushala. This is the third instance of li-

ons being spotted in Rajkot district in a month. Seven lions were found camping in Thanagalol village. 10 km north of Arab Timbadi last month, and three lions killed 14 cattle earlier this month in Jasdan taluka

"The pride of 10 lions managed to enter the gaushala at around 3 am Tuesday and went on the rampage, killing 10 cows. However, a team of forest department reached the spot soon and saved 25 other cows," Nishant Kugasiva, taluka development officer (TDO) of Jetpur, told The Indian Express.

DSP ADIKO and DSP HMK are private limited companies incorporated in 1983 under the Companies Act, 1956 and are also registered with the Reserve Bank of India as Non-Deposit taking Systemically Important Non-Banking Finance Companies. These companies have been functioning as investment companies.

DSP ADIKO is 99.98% owned by the DSP ADIKO Trust and DSP HMK is 99.98% owned by the DSP HMK Trust. Aditi and Shuchi each hold 0.01% of the paid-up equity share capital of both these entities.

THE PROPOSED TRANSACTION:
