Central Railway will operate Mega Block on its suburban sections for carrying out maintenance work on 19.04.2015 :-

THANE - KALYAN DN FAST LINE FROM 10.30 A.M. TO 3.00 P.M.

- Dn fast services leaving Chhatrapati Shivaji Terminus Mumbai from 9.37 am to 2.25 pm will halt at Ghatkopar, Vikhroli, Bhandup and Mulund stations in addition to their respective scheduled halts. Dn fast services beyond Thane will be diverted on Dn slow line between Thane and Kalyan stations halting at all stations and will arrive destination 20 minutes behind schedule.
- Up fast line services leaving Thane station from 10.46 a.m. to 3.28 p.m. will halt at Mulund, Bhandup, Vikhroli, Ghatkopar and Kurla stations in addition to their respective scheduled halts and will arrive destination 15 minutes behind schedule.
- Dn Mail/Express trains leaving Thane from 11.21 a.m. to 2.43 p.m. will be diverted on Dn slow line between Thane and Kalyan Stations.

Rescheduling of Express train :-

KURLA - CHHATRAPATI SHIVAJI TERMINUS UP HARBOUR LINE & VADALA ROAD-MAHIM UP AND DN HARBOUR LINES FROM 11.30 A.M. TO 3.30 P.M.

- All DN harbour line services to Bandra / Andheri leaving Chhatrapati Shivaji Terminus Mumbai from 10.20 a.m. to 3.33 p.m. and UP harbour line services for Chhatrapati Shivaji Terminus Mumbai leaving Bandra / Andheri from 10.40 a.m. to 3.17 p.m. will remain suspended.

- Harbour line passengers for Bandra/ Andheri are permitted to travel via Main Line and Western Railway from 10.00 a.m. to 6.00 p.m.
