Sub: Intimation in terms of SEBI Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated November 6, 2018 pertaining to transfer of securities in physical mode

Board of India (SEBI), The Securities and Exchange vide its Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated November 6, 2018, prescribed the standardized procedure for effecting transfer of securities in physical mode, including cases involving material mismatch of name/non-availability of transferor's signature. Further, SEBI vide its Circular No. SEBI/HO/MIRSD/RTAMB/CIR/P/2020/166 dated September 7, 2020, had fixed March 31, 2021 as the cut-off date for re-lodgment of transfer requests in physical mode and stipulated that such shares be issued only in demat mode. Further, SEBI vide its Circular No. SEBI/HO/MIRSD/RTAMB/CIR/P/2020/236 dated December 2, 2020 had prescribed the operational guidelines for transfer and dematerialization of re-lodged physical shares.
