The bod-ies were found in a five-sto-ry building that collapsed in March in Eyyun, about 200 kilometers from the city of Kharkiy, which has been un-der sutstained Russian at-tack since the beginning of the war in late February. the war in late February. Earlier, the Ukrainian mil-itary said Russian forces fired seven missiles a day

earlier from the air at the

earlier from the air at the crucial Black Sea port of Odessa, hitting a shopping center and a warehouse. One person was killed and five were wounded. Ukraine alleged at least some of the munitoni used, making thou mureliable in margeting. Ukrainian, British and American officials have warned that Russin is rapid-ly expending its stock of precision weapons and may not be able to quickly build more, raising the risk of more imprecise rockets be-ing used as the conflict grinds on. That could result in wider damage and more civilian deaths.
