Jharia Division of Tata Steel Ltd. is committed to improve safety and environment by strictly practicing Environmental Management System of company. Various programs are arranged such as World Environmental day, World Earth Day, International Day for Biological Diversity, Annual Flower Show etc. for public awareness. Also, various initiatives for biodiversity enhancement in the region have been taken such as Bird Niche Nesting, Development of Butterfly garden, Medicinal Garden, Nursery development of native species, etc. Tree plantation will be continued in the leasehold area. Water pumped out of the mine will continue to be used in washery other than use in stowing. Four Effluent Treatment Plants based on MBBR technology have been commissioned with capacity of 10 KLD each for canteen wastewater at JCPP, 2-Pit, workshop effluents treatment & TMH. Three STP of 50 KLD, 60 KLD and 30 KLD has been installed for sewage treatment of residential colonies. Two continuous ambient air quality monitoring system and one PM 10 station has also been installed in the area.

1. We are providing safe drinking water from our water treatment plant & MADA to our employees.
2. We are regularly sprinkling water in an around the units, to suppress dust.
3. Our welfare department arranges to clean the domestic garbages from our colonies to provide better environment.
4. Regular monitoring of Air Quality & mine water analysis by our separate environment management cell.
5. We have already done the tree plantation job and this is a continuous process in company leasehold areas.
6. Regular thrust on Environment awareness conducting training classes at P.T.I., Jamadoba.
7. We are an IMS certified unit (ISO 9001:2015, 14001:2015 and 45001:2018 certified) along with SA:8000 (Social Accountability)
