2 Tata Sons Private Limited (TSPL) holds 31.76% in Tata Steel Limited as on September 30, 2024 and Tata Steel Limited is an associate of TSPL. TSPL being a Core Investment Company registered with RBI, is exempted under the Significant Beneficial Ownership (SBO) Rules. The Company does not have any other Significant Beneficial Owner under SBO Rules to be reported in the shareholding pattern as on September 30, 2024.																	
3 The total number of Ordinary Equity Shares include 4,370 Ordinary Equity Shares of face value Rs.1/- each on which first and final call money has been received and the partly paid-up equity shares have been fully converted to fully paid-up equity shares but, are pending final listing and trading approval under the ISIN INE081A01020 (ISIN for fully paid-up shares), and hence, continue to be listed under the ISIN IN9081A01010 (ISIN for partly paid-up shares) as on September 30, 2024.

5 Tata Capital Financial Services Limited (TCFSL) has been merged with Tata Capital Limited effective January 1, 2024. Accordingly, the entire holding of TCFSL in the Company, (8,210 Ordinary Equity Shares) has been transferred from TCFSL to Tata Capital Limited and NIL holding is reported against TCFSL appearing in the above table under the Promoter Category.
