FIRST YEAR JUNIOR COLLEGE ADMISSION

Students can select college from across state, says Palkar

IN A FIRST, students seeking admission to First Year Junior College (FYJC or Class 11) in Maharashtra will have a choice to select any college from across the state while submitting an online Centralised Admission Process (CAP) extended across state. At the same time, if a candidate fails to provide supporting documents, including valid marksheet at the time of verification; he/she will be barred from the process until the last round of admissions.

As the CAP for FYJC opens for practice session for students' registration on Monday, MAHESHI PALKAR, Director of Education (Secondary), Maharashtra speaks to PALLAVI SMART to clear doubts about the process while highlighting important aspects for aspirants to be cautious about.

Is there any change in the FYJC admissions this year?

Starting from the academic year 2023-24, Class 11 admissions across the state will be conducted through the online CAP, unlike the past, where online FYJC admissions were limited to five regions — cities in Mumbai Metropolitan Region (MMR), Pune-Pimpri-Chinchwad, Nagpur, Nashik, and Amravati. Aimed at bringing uniformity and transparency to the admission process across the state, there will be a single portal, as opposed to previous practice of one dedicated portal for each region.

Candidates will have the liberty to choose any junior college

from across the state in their options of colleges filled in the admission application in order of their preference. For example, a student in Mumbai will also get to submit an admission application for a junior college offer choice in Pune through the single portal. Even as the online CAP is extended to the entire state, the technical process remains the same.

What is the process?

In the first phase, aspirants seeking FYJC admissions should register on the portal—<https://mahajyadmissions.in/landing>. Practice session for registration will begin on May 19, official candidate registration will begin on May 21 and will continue till May 28. Students are given log-in details through the information booklet circulated via their respective schools. The information booklet is also available on the portal.

At the time of applying for admissions, candidates have to

choose minimum one and maximum 10 junior colleges in order of their preference. After completion of the application registered digitally by unverified sources, there could be individuals assuring admissions. Candidates and their parents need to know that the official admission portal is the single source of admission as well as information on the FYJC admission. This year there is a dedicated helpline for FYJC admissions — 8530955564.

All junior colleges have been instructed to conduct thorough verification of documents at the time of admission. This process may also include an additional layer of verification by a senior admission authority, if necessary. Candidates who fail to provide valid proof for any information submitted in their application—including a valid marksheet—will be disqualified from participating in all regular admission rounds. Such candidates will only be eligible to participate in the final special round, which will be conducted for the remaining vacant seats.

No formal opposition has been submitted to this office. Over 9,000 junior colleges across the state have already completed the registration process. There are 2,043,254 seats available for FYJC admissions across the state that includes 8,52,206 seats under science stream whereas 5,40,312 and 6,50,682 seats in Commerce and Arts stream respectively.

What should the candidates

be careful about while participating in online CAP? Apart from fake websites and incorrect information circulated digitally by unverified sources, there could be individuals assuring admissions. Candidates and their parents need to know that the official admission portal is the single source of admission as well as information on the FYJC admission. PROPERTY DISPUTE

41 held after guard opens fire on rival firm security

TWO SECURITY companies hired by two rival pharmaceutical companies over possession of a plot of land in Agripada got into a fight that led to one of the security guards opening fire from his gun. The other security group then called up the police control room following which an FIR was registered by the Agripada police which arrested 41 persons in connection with the case.

According to Agripada police, a plot on the Bapurao Jagtap Marg near Jacob Circle in Agripada has been a subject of dispute between a real estate and pharmaceutical company. The police said a lower court had ruled in favour of the real estate

company and the Bombay High Court had recently sought a status quo on the matter after the pharmaceutical company had gone in appeal.

However, security agencies employed by the two companies got into a dispute on Saturday night around 10pm. As per police, the guards and bouncers belonging to the pharma company allegedly sprayed pepper spray on the guards belonging to the real estate company and threw stones at them.

When the two sides came face-to-face following this, it was alleged that one of the bouncers of the pharma company who had a licensed double-barrel gun fired a round in the direction of the rival security guards following which the latter called up the police control room.

A police team reached the spot and took the accused to the Agripada police station where an FIR was registered against them. Based on the FIR, a total of 41 persons from the security agency representing the pharmaceutical company were placed under arrest. They were produced before the court and were remanded to police custody for a day.

Five convicted in 'petty organised crime' case get one year in prison

IN ONE of the initial cases of conviction under the newly introduced Section 112 for "petty organised crime" under the Bharatiya Nyaya Sanhita (BNS), five persons arrested for chain snatching by the Mumbai Police during the Ganesh Chaturthi festival were found guilty by a court on Friday and were sentenced to one-year rigorous imprisonment.

According to police, on September 20, based on a complaint by B Shikhi that his phone was stolen during Ganesh visar-

jan procession, an FIR was registered at the VP Road police station. When it came to light that several such mobile theft cases were registered, DCP (Zone II) Mohit Garg formed a team to probe these cases.

During investigation, five accused were arrested who were identified as Sanjay Raman Khawar, Sanjay Suresh Khawar, Suresh Rajendra Lohikar, Lalit Tunu and Akash Vijay Mehra. A total of 42 mobile phones and five different brands and a two-wheeler were seized from them.

Based on the past record of the accused, they were prosecuted under Section 112 (petty organi-

zed Crime) of the Bharatiya Nyaya Sanhita that came into effect across the country on July 1, 2024. This section was introduced to deal with cases where the crime may not be serious but is carried out by gangs. In case of serious offences such as murder, acts like the stringent Maharashtra Control of Organised Crime Act (MCOCA) is used in the state.

On May 16, the Girgaon court, after completing the hearing of the trial found the five accused guilty and sentenced them to one year rigorous imprisonment under Section 303 (2). The court also imposed a fine of Rs 5,000 per person.

13 hospitalised after dimethyl sulphate leak in chemical unit

THIRTEEN WORKERS were hospitalised after dimethyl sulphate leaked in a chemical manufacturing unit in the early hours of Sunday in Maharashtra's Palghar district, officials said.

The incident took place around 3am at a unit in Boisar Tarapur MIDC, said District Disaster Management Cell chief Vivekanand Kadam.

Dimethyl sulphate is a clear,

oil liquid with a faint onion-like odour and can cause skin and eye irritations as well as burns.

"The unit in which dimethyl sulphate leaked makes antioxidants. The leak took place when dimethyl sulphate was being transferred from the unit's plant 4 to plant 10. The fumes emanating following the leak caused irritation in the eyes of workers," Kadam told PTI.

As a precautionary measure due to the nature of the chemical exposure, 13 workers were hospitalised, he said, adding the in-

cident was reported to his cell at 12:35pm. "The probe into the incident is being carried out by SG Babbar, assistant director of the Directorate of Industrial Safety and Health. The probe will cover safety protocols in place during the chemical transfer process and overall adherence to industrial safety norms," Kadam informed.

A local fire brigade official said his department was not informed about the incident as the company handled the situation by itself. PTI

'Trying to politicise Op Sindoor': Cong criticises BJP's Tiranga Yatra

CRITICISING THE "Tiranga Rallies," the Congress Sunday alleged that the BJP was trying to politicise the "victory of Indian armed forces" over Pakistan during Operation Sindoor. "BJP is taking out Tiranga Rallies to celebrate the victory of our armed forces during Operation Sindoor. This is an attempt to politicise the issue and claim wrong credit. When they are taking out 'Tiranga rallies,' the BJP should remember that our armed forces lost 7 jawans. We should take revenge for our loss. Of the 8 jawans who became martyrs, 7 are from Maharashtra," said Congress spokesperson Gopalada Tiwari. The Congress said the BJP was trying to hijack the heroics of the armed forces in view of the ensuing elections. "This

is highly condemnable," he said. Tiwari said that the BJP should remember that all political parties, including Congress had given full support to the Modi Government to take action against Pakistan which was sponsoring terrorism. Rahul Gandhi showing distrust in our armed forces, says Fadnavis

CHIEF MINISTER Devendra Fadnavis Sunday slammed Congress leader Rahul Gandhi for allegedly showing distrust in the armed forces in the wake of Operation Sindoor, which he said revealed India's self-reliance and extraordinary military capabilities.

Gandhi, in a post on X Saturday, said, "Unfortunately, at a time when everybody is celebrating their political differences, we see Opposition Leader Rahul Gandhi questioning the government and showing a lack of trust in the armed forces." SEVEN MEMBERS OF Parliament (MPs) from Maharashtra are among the top 17 MPs from both Lok Sabha and Rajya Sabha who have been nominated to receive the prestigious Sansad Ratna Awards 2025. Two parliamentarians have also been nominated for the award.

Supriya Sule, Nationalist Congress Party (Sharad Pawar) MP from Baramatoli Lok Sabha constituency, Shirang Bhatnagar, three-time MP from Pune's Maval Lok Sabha Constituency; Rajya Sabha MP Medha Kulkarni; Congress MP Varsha Galkwad; Smita Uday Wagh (BJP); Arvind Ganpat Sawant (Shiv Sena UPT); and Nareesh Ganpat Mahase (Shiv Sena), are the awardees from Maharashtra. The Sansad Ratna Awards were instituted in 2010 by Prime Point Foundation and the eMagazine PreSense, following the suggestion of Dr APJ Abdul Kalam. Dr Kalam also inaugurated the first award ceremony in Chennai in May 2010. Hansraj Gangaram Ahir was the first recipient of the award. As of 2024, 125 awards have been presented across 14 award ceremonies, recognising individual parliamentarians and parliamentary standing committees.

This year, 17 individual awards will be conferred.
