This is with further reference to our letter dated 1st July 2014 enclosing the Notice alongwith Explanatory Statement for seeking the consent of Shareholders by Special Resolution vide a Postal Ballot for the following items :-

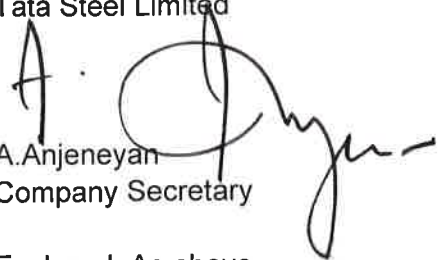
1. Increase in borrowing limits from Rs.50,000 crores to Rs.70,000 crores or the aggregate of the paid up capital and free reserves of the Company, whichever is higher.
2. Creation of Charges on the movable and immovable properties of the Company both present & future, in respect of borrowings.
3. Further issuance of privately placed debt securities (convertible into equity or otherwise) in the international and/or domestic capital markets for an amount not exceeding Rs.14,000 crores.

The three Special Resolutions set out in the Notice of the Postal Ballot dated 17th June, 2014 require more than three-fourths of the number of votes to be cast in favour of each of the Resolutions in order to pass the Resolutions.

In connection with the above and pursuant to Clause 35A of the Listing Agreement, we would like to inform you that Resolutions No.1, 2 and 3 mentioned in the aforesaid Notice were passed by the Shareholders by the requisite majority.
