

**NAGPUR:** Abdul Gani Turk, a 1993 Mumbai serial blasts convict lodged at the Nagpur Central Jail, died on Thursday, an official said. Turk, 68, was lodged in the Nagpur Central Jail since 2012. Convicted for planting a bomb at Century Bazar, one of the 12 sites devastated by serial blasts in the country's financial capital on March 12, 1993, Turk was serving life imprisonment after his death sentence was

commuted. At least 257 people died in the blasts. Jail superintendent Rani Bhoale said that Turk was not keeping well for some time and was taken to the Government Medical College and Hospital (GMCH) here on April 22. Later he was brought back and being treated at the prison hospital. He fell unconscious on Thursday morning and was rushed to the GMCH where he was declared dead. - Agencies

They clarified that they are against the sitting Member of Parliament and Maha Yuti candidate Rajan Vichare. They clarified, "We have been repeatedly humiliated and finally we decided to oppose Vichare," said RPI spokesperson Vikas Chavan. RPI workers claimed that they were always ig-



nored and not invited to any conference and meetings. "We are not called. Our party is not acknowledged and worse photographs of Athavale and district chief Rambhau Tayade are not displayed on publicity hoardings," said Chavan. The workers said none of Maha Yuti say 'Jai Bhim' at meetings and they are always given the back seats on the stage. Chauhan claimed they have rebelled despite Athavale and Tayade asking them to refrain from doing so. Chavan said that they are ready to face any action.

### Ahmednagar district Congress chief quits

Congress received yet another setback in Ahmednagar as the district chief Karan Sasane resigned from the party. "I will not campaign for Congress party and will remain neutral," said Sasane. Sasane took this decision after a joint meeting with supporters Radhakrishna Vikhe Patil at Shir-di. In this meeting, Sasane took the decision to step down as Congress district chief. He said that the workers are upset with Bhausaheb Kamble. "We only worked because of our commitment to the party and we took sabhas. After my father was humiliated, I refused to work anymore for the elections. I am not going to work against the party but I will not campaign for it," clarified Sasane. Congress president Rahul Gandhi's concluding public meeting is going to be held in Sangamner and it remains to be seen if Vikhe Patil attends it. Dr Sujay quit Congress and is now a candidate of Maha Yuti. Vikhe Patil has said that he will clarify about his future plans on April 27.

### BKC road restricted on Friday for Jahir Sabha organised by political parties

**MUMBAI:** The Bandra Kurla Complex traffic Police have issued a circular mentioning the traffic diversions near the MMRDA ground on account of the Jahir Sabha organised by political parties on Friday. The circular states that vehicular entry on both sides of the road between Tata Power building and fire station building at BKC will be temporarily restricted from Thursday midnight to Saturday midnight. On the same lines, the entry on BKC road from NABARD junction to UTI will be restricted, said a traffic police officer. These restrictions are not applicable to emergency vehicles like fire tenders and ambulances. The traffic police have advised the commuters to plan their travelling schedule accordingly.

#### Six women, among ten, held in bar raid at Kashmirira

**BHAYANDAR:** The Anti-Human Trafficking Unit (AHTU) of the Thane (rural) police raided a ladies' bar in Kashmirira and apprehended ten people including six women late on Wednesday night. Acting on a tip-off, a police team swooped down on Hotel Sea Magic, a ladies' bar located on the Penkarpada Road which was reported to be indulged in late night raunchy and vulgar shows under the guise of live orchestra performances. Ten people including the cashier, singers and waitresses were rounded up and booked under Sections 109, 114 and 294 of the Indian Penal Code. However, as usual the operator and original owner of the establishment who are the actual beneficiaries of the vulgar trade have not only managed to evade the police dragnet, but their identity is yet to be ascertained. Cash amounting Rs 10,200 was seized during the raid. Further investigations were on. - Suresh Golani

#### Elderly man dies after police take his grandson into custody

**MUMBAI:** A 70-year-old man died apparently due to shock after his minor grandson was taken into custody by police in connection with a stone pelting incident in Osmanabad, an official said on Thursday. Dattu Ganpati More died immediately after police apprehended his grandson from their house in Telmod village in Umarga taluka late on Wednesday night, the official said. More's grandson was held as part of the operation launched to catch those allegedly involved in pelting stones at a police vehicle, he added. "More's grandson and some other persons were found involved in hurling stones at a police vehicle over its alleged delay in reaching the spot of a car

accident in which three people had died. The accident had taken place on Sunday," the official said. The stone-pelters had later escaped from the spot. The police had registered an offence against a group of at least 25 persons, including More's minor grandson.

#### Man gets life sentence in bank loan fraud case

**THANE:** A special court for CBI cases here has sentenced a 38-year-old man to life imprisonment for fraudulently obtaining loans of over Rs 2.80 crore from the Andhra Bank in 2008. Then manager of the bank's Ghodbunder branch in neighbouring Thane was awarded 10 years' jail term, while three others were sentenced to three years' imprisonment for conspiracy on Thursday. Besides awarding him life imprisonment, CBI Judge S R Tamboli also imposed a fine of Rs 3.13 crore on prime accused Rajendra Patil. Bandlamudi Mahipal, the former branch manager, was ordered to pay Rs 3.40 lakh. The accused were held guilty under IPC Sections 420 (cheating), 467 (forgery of valuable security), and 120 B (criminal conspiracy) as well as under the Prevention of Corruption Act. According to the prosecution, Patil approached Andhra Bank's Ghodbunder Road branch for a vehicle loan and a loan against property in 2008. - Agencies

### Man gets 10-yr RI for raping minor girl in Maharashtra

A 33-year-old man has been sentenced to 10 years' rigorous imprisonment by a Thane court in Maharashtra for raping a minor girl in 2015.



District and special POCOS court judge S B Bahalkar on Wednesday pronounced the punishment to the accused, Shivmani Ramdulhar Jaiswar, who worked as a carpenter, and also imposed a fine of Rs 27,000 on him. According to the prosecution, the accused and the victim, then aged 10 years, were neighbours in the city's Manorama Nagar area and knew each other. On July 17, 2015, the accused went to the girl's house when she was alone and raped her. He threatened her with dire consequences if she revealed about the offence to anyone, the prosecution told the court. The girl later informed her mother, who lodged a police complaint following which the accused was arrested and booked under Indian Penal Code Sections 376(2)(i) (rape) and 506 (criminal intimidation), and provisions of the Protection of Children from Sexual Offences (POCSO) Act. The judge, while pronouncing the sentence, held that the prosecution proved beyond reasonable doubt all the charges against the accused.
